RULES AND REGULATIONS OF THE TRAILER HOUSE



I. GENERAL PROVISIONS

The Rules and Regulations posted on www.czasnamolo.pl define the conditions of reservation and rental of trailer house.

Making a reservation is tantamount to knowing and accepting the provisions of these Regulations.

II. ACCOMMODATION

- 1. Check-in time from 2 P.M. to noon next day.
- 2. Check-in possible until 8 P.M.
- 3. The fee for the entire stay is paid at check-in.
- 4. We reserve the right not to give keys to persons under the influence of alcohol, intoxicants, and people behaving aggressively and posing an immediate threat to other people and property.
- 5. The key to the cottage is issued only against a refundable deposit of 100 PLN.
- 6. Each magnetic card allowing access to the camping area is issued only against a refundable deposit of 20 PLN / piece.
- 7. In the case of a deposit, we accept only cash.
- 8. The campground staff may ask guests, before checking out at the reception desk to check the cottage left together. The check will be mainly on the conformity of equipment. In case of discrepancies and deficiencies, a fee will be charged in accordance with the applicable price list available at the campground reception.

III. USE OF THE TRAILER HOUSE

1. The renter is obliged to familiarize himself with the actual state of the cottage, its equipment, as well as the regulations.

Comments on damage and destruction of trailer house should be immediately reported to the reception staff.

- 2. The landlord is financially responsible for damage caused during his stay.
- 3. The landlord is obliged to leave the house and all equipment in the same condition in which he found it.
- 4. Smoking is strictly prohibited inside the cottage. In case of violation of this point, the facility may charge the guest a fine of 500 PLN.
- 5. In the event that the guest significantly violates the peace of other guests of the campsite and does not respect the generally applicable norms of coexistence between people, we reserve the right to terminate the rental agreement with immediate effect and is not entitled to a refund for unused stay.
- 6. Due to fire protection requirements in the cottage, which is a place of accommodation, it is not allowed to use any appliances or apparatuses powered by electricity or gas, which are not the equipment of these rooms and which may create a fire hazard, such as electric heaters, heaters, gas burners, etc., in the cottage. It is forbidden to bring flammable materials, explosives and materials with an unpleasant odor into the cottages.
- 7. Quietness of the night is in force in the entire campground from 10 P.M. to 6 A.M.
- 8. We are not responsible for valuables and money left in it. Please exercise due diligence related to closing windows and doors when leaving the cottage.
- 10. The Guest may not transfer or share the cottage with other people.

IV. PARKING

1. parking of the car is possible only in the designated place.

V. OTHER PROVISIONS

- 1. The Lessor agrees to the processing of personal data solely for the purpose of carrying out the reservation and rental agreement and fulfillment of the registration obligation in accordance with the provisions of the Act of Article 13 (1) and (2) of the Regulation of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons in relation to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation Official Journal of the EU L 119 RODO).
- 2. We are not responsible for temporary inconveniences occurring through the fault of independent suppliers caused, for example, by temporary lack of water, electricity.
- 3. The law applicable to disputes between the Owner and the Landlord is Polish law. Any disputes will be resolved amicably, and in case of disagreement the competent court will be the court having jurisdiction over the registered office of the Owner.
- 4. Matters not covered by the regulations shall be governed by the provisions of the Civil Code.
